In consideration of my participation in JFCS programs, services, and/or activities, including volunteer opportunities, the undersigned participant, agrees to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of, or in any way relating to, COVID-19. I hereby certify that I have full knowledge of the nature and extent of the risks inherent in participation and that I am voluntarily assuming said risks. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death, I sustain while participating in all JFCS programs, services and/or activities, including volunteer opportunities, and that by signing this agreement I HEREBY RELEASE Releasees from all liability for such loss, damage, or death arising out of, or in any way relating to, COVID-19.
