DUTIES AND RESPONSIBILITIES:

- Conducts psychiatric assessments and renders diagnosis in accordance with current DSM, within program time frame guidelines
- Evaluates need for medication and prescribe medications for agency clients
- Provides ongoing medication management for agency clients
- Prescribe medications within standards of current psychiatric care
- Order and review lab tests according to clinical indications
- Participates in joint clinical case review meetings and service planning to coordinate care for clients
- Provides psychiatric emergency intervention and management for agency clients
- Performs risk assessment of agency clients, if available/time permits
- Facilitates access to psychiatric higher level of care, if needed
- Maintains documentation as per agency and state standards
- Engages with supervising physician as per Collaboration Agreement, including consultations and record reviews, periodically and/or as clinically indicated
- Participates in quality assurance process
- Provides staff training, consultation and support in medication education and recordkeeping
