FY 2021 -- \$130 MILLION

FY 2022 -- \$280 MILLION

+ \$150 MILLION CHANGE

EMERGENCY FOOD AND SHELTER PROGRAM

Eligible Services and Supplies:

- **Food Services**
- **Shelter Services**
- **Supplies and Equipment Purchases**
- **Utility Services for Clients: (e.g., gas, electric, water)**
- **Administrative Allowance**

For nonprofit, faith based, and governmental organizations

ADMINISTRATION FOR COMMUNITY LIVING

FY 2021 -- \$2.29 BILLION

FY 2022 -- \$2.35 BILLION

+ \$60 MILLION CHANGE

OLDER AMERICANS ACT PROGRAMS

\$49.5 MILLION IN TOTAL INCREASES:

- Home-delivered meals \$291.3 million (+\$15m)
- Congressionally directed programs (new +\$14m)
- Home and community-based services \$392.6 million (+\$6m)
- Caregiver support \$205 million (+\$5.5m)
- Alzheimer Disease \$14.8 million (+\$2m)
- Aging network support activities \$18.6 million (+\$2m)
- Other miscellaneous programs (+\$5m)

FLAT-FUNDED OAA PROGRAMS

- Congregate meals (\$515.3m);
- Other nutrition services (\$160m);
- Preventive health programs (\$24.8m)
- Community Services Employment (DOL Program, \$405m)

HOLOCAUST SURVIVOR ASSISTANCE PROGRAM

Included within ACL's Aging Network Support Activities (\$18.641m)

- FY 2021 -- \$5 million
- FY 2022 -- \$6 million
- Up \$1 million!

DISABILITY-RELATED PROGRAMS AT ACL

Most flat-funded except for:

- National Institute on Disability (+\$3.5m)
- Developmental Disability (+\$2.5m)
- Independent Living (+\$2m)
- Assistive Technology (+\$1m)
- Traumatic Brain Injury (+\$0.5)

Total = +\$9.5m

DEPARTMENT OF HOUSING & URBAN DEVELOPMENT

\$53.76B TOTAL FUNDING (UP \$4B/8%)

HUD Section 202 (older adults):

- \$1.033 billion in program funding (\$178m/21% increase)
- \$125 million dedicated to service coordinators
- 2200 new units

HUD Section 811 (persons with disabilities)

- \$352 million in program funding (\$125m/55% increase)
- 1800 new units
